He also reported that the results from the survey were in. NHCEMS is ranked 42nd out of 241 districts. Lowest score was based on comfort of ride.

Matt Weinberg reported that there were 244 total calls. We are averaging 110-115 transports a month. Matt reported that NHC EMS had an average overall response time of 9:10. Also, Medic 75 should be back in March.
